Directions:

Go right onto 26N, past Poland Spring Inn. Take first left onto Schillinger Road. Take the first right onto Jackson Road (0.3 miles). Valenti's is the fourth house on the left. House is at end of driveway.

From the South, take I-95 to Gray exit 63. Take right onto 202E. Take next left at light onto Rt. 26N. Go approx. 11.7 mi. into Poland Spring, pass the Inn. Turn left onto Schillinger Road. First right onto Jackson Rd. Valenti's is 4th house on left.




